# Free Zone Establishment (FZE)

An FZE license is under the category of a single shareholder and will enjoy the status of a totally independent corporate entity. This structure is perfect for sole proprietors and individual entrepreneurs who want complete control over their business operations while benefiting from limited liability protection.

The FZE structure provides the flexibility and autonomy needed for rapid decision-making and streamlined operations, making it an attractive option for startups and individual business owners.

## Required Documents:

- Passport copy
- Colored photograph
- Residence visa and Emirates ID copy (if resident)
- Tourist visa / Entry stamp (if tourist visa)



# Free Zone Company (FZC)



An FZC is a business entity with the capacity to have two or more shareholders. The name of an FZC reflects its shareholder structure, making it ideal for partnerships, joint ventures, and businesses with multiple investors.

This structure enables shared ownership, collaborative decision-making, and the ability to pool resources and expertise from multiple stakeholders. It's particularly beneficial for businesses looking to expand with strategic partners.

## Required Documents (for all shareholders):

- Passport copy
- Colored photograph
- Residence visa and Emirates ID copy (if resident)
- Tourist visa / Entry stamp (if tourist visa)

# Branch Company Options

Expand your existing business operations to the UAE through our branch company structures. We facilitate both foreign and local company branches, each designed to meet specific regulatory requirements and business needs.

## Branch of Foreign Company

Companies based outside of the United Arab Emirates are granted licenses under this category. The corporation will have 100% foreign ownership, maintaining complete control of operations.

### Required Documents:

- Passport copy of the Company Manager
- Colored photograph of the Company Manager
- Residence Visa and Emirates ID copy (if resident)
- Tourist Visa / Entry stamp (if tourist)
- Trade License Copy (Attested)
- MOA Copy (Attested)
- Board Resolution Copy (Attested)

**Attestation Requirement:** Foreign company documents must be attested by Foreign office & UAE embassy in country of issue, followed by Ministry of Foreign Affairs attestation in UAE.

## Branch of Local Company

A company holding a valid license from any other UAE licensing authority is eligible for this license, enabling expansion from mainland to free zone.

### Required Documents:

- Passport copy of the company manager
- Colored photograph of the company manager
- Residence visa and Emirates ID copy (if resident)
- Tourist visa / Entry stamp (if tourist)
- Trade License copy (Notarized and Attested)
- MOA Copy / AOA Copy (Notarized and Attested)
- Board Resolution copy (Notarized and Attested)

**Attestation Requirement:** UAE company documents must be notarized from Notary Public in UAE or attested by license issuing authority in UAE.
